**DIRECTIONS TO M&T BANK STADIUM, LOT B**

**From I-95 North of Baltimore**

- \* Take Exit 53 off I-95, Roadway becomes I-395.
- \* Stay in the Right lane and take the first exit on the Right (Russell Street).
- \* Proceed to traffic light.
- \* Take a Left at the traffic light onto Lee Street/Ripken Way.
- \* Turn Left into Lot B.

**From the South via I-95**

- \* Take Exit 52 to Russell Street.
- \* Stay in the Right lane.
- \* As you pass M&T Bank Stadium, and just prior to Hamburg Street, veer Right onto Russell Street Service Drive.
- \* Turn Right on Hamburg Street.
- \* Turn Left into Lot B.

**From the South via I-295**

- \* Take Baltimore/Washington Parkway (295) North to Baltimore.
- \* I-295 becomes Russell Street.
- \* As you pass M&T Bank Stadium, and just prior to Hamburg Street, veer Right onto Russell Street Service Drive.
- \* Turn Right onto Hamburg Street.
- \* Turn Left into Lot B.

**From Downtown**

- \* Take Russell Street South
- \* Turn Left at Lee Street.
- \* Turn Right onto the Service Road.
- \* Turn Right into Lot B.

**PARKING IS FREE – LOT B**

From the parking lot walk to M&T Bank Stadium, follow the crosswalk across the street to the North West Suite Entrance which is to the Right of the Johnny Unitas statue. Take the elevator to the 2<sup>nd</sup> Floor. The Seminar is in the North Club Lounge.
